A Pioneer Perspective

Scholarships an important part of history and mission

Kent Ryan on 25 Years of the Clinton County Community Foundation

Since 1996, the Clinton County Community Foundation has established itself as a trusted organization providing valuable leadership in the community.

As an affiliate of the neighboring Community Foundation of Howard County Inc., almost from the start Clinton County's Foundation was able to position itself to continue a rich heritage of local philanthropy and to provide new opportunities for donors.

Today, the Foundation has made grants of more than \$11.3 million to help make Clinton County a better place. This amount includes approximately \$8.7 million in grants and \$2.6 million in scholarships, with an additional \$2.8 million in Lilly Endowment Community Scholarships.

The Foundation has been able to support a range of programs and local organizations through strong leadership and the sustaining commitment of community-minded volunteers. Through their vision, effective organization and good stewardship, the Foundation for 25 years has been a catalyst for stimulating and funding initiatives that improve the quality of life for citizens of Clinton County.

Longtime Frankfort, Indiana, attorney Kent Ryan was part of the pioneer group who organized the Foundation, and we asked him about his thoughts on the first 25 years.

What was the impetus for creating an affiliate foundation for Clinton County in 1996?

At the time, the guiding light was the late legendary Bill Beard of Frankfort, Indiana, a successful local business leader and a devoted champion of Clinton County. Bill spearheaded the effort to see how the community could benefit from a Community Foundation. Based on his research, our volunteer action committee decided the best course was to seek to join an existing foundation. We were very glad when Steve Alley of the nearby

Community Foundation of Howard County welcomed us as an affiliate.

What was funding like from the start?

We started with \$30,000 and some generous seed money from members of the community. We had a great board of directors made up of several community leaders, who helped organize fundraising and steered the Foundation to really maximize the Lilly Endowment Inc. Giving Indiana Funds for Tomorrow (GIFT) Initiative.

Was there a specific need being addressed for the community?

Well, we really positioned the Foundation to be an adjunct to the United Way in our community. The idea was the United Way would be the checkbook, and the Foundation would

be the bank account.

What were some of the early success stories?

From a community donor perspective, ongoing support of the Boys and Girls Club of Clinton County has been a significant source of pride for the Foundation. In terms of scholarships, Clinton County's very first Lilly Endowment Community Scholarship recipient was able to attend Rose-Hulman Institute of Technology in Terre Haute, Indiana. Coincidentally, the current chair of the Clinton County Community Foundation Services Committee – attorney Alicia K. Albertson – was a Lilly Endowment Community Scholarship recipient from Huntington County, Indiana, in 2008.

Any other thoughts about the milestone?

From the start, the Foundation was well-thought-out, well-planned, and well-accepted. The completed projects after 25 years are amazing. That it continues to thrive speaks to the tremendous group of leaders who have donated their time and talents through the years.

The finalists' names were submitted to Independent Colleges of Indiana (ICI) for the selection of the recipient. ICI is a nonprofit corporation that represents 30 regionally accredited degree granting, nonprofit, private colleges and universities in the state.
